### **INTERNATIONAL NEWS**

Ducati is recalling the 2011-2012 Monster 1100 EVO because of potential cracks developing on the rear wheel spokes. The affected units have rear wheels labeled "DU6-RR". Rims with the code "DU6N-RR" are not included in the recall campaign.

According to documents released by the National Highway Traffic Safety Administration, the spokes the rear wheel of some units may crack after intense use or after logging a lot of mileage, estimated by Ducati to be equivalent of six years' worth of average use.

The problem was first identified in November 2011 during development of a different model which uses a similar wheel design (possibly the Streetfighter 848 which uses a similar 10-spoke 5.50x17 wheel). Ducati examined its Monster 1100 EVO test units and found one with 26,888 miles on it with cracks on two spokes.

To resolve the issue, Ducati designed a new wheel with supplier Enkei Thai. The new wheels are labelled "DU6N-RR" instead of "DU6-RR".

Ducati dealers will replace the rear wheels on affected units at no charge to the motorcycle's owner. The recall campaign affects 892 units.

CO poisoning on a bike? It Can Happen

This is a bit long but I think an interesting story and important.

In 2006 we were riding to Alaska from our home in Langley. We rode north through BC with the route becoming more and more remote the further north we got. Anyone who rides long distances knows that it's not unusual to get a little drowsy on long stretches but we began to experience

something that was definitely different. We weren't just getting drowsy, we were having outright nap attacks right out of the blue. We would be fine for hours then so sleepy we had to pull over to take a nap. Not only that, I couldn't shake an unusual feeling of dread. Had we bitten off more than we could chew? We were in pretty remote territory but we had been before and had never felt like this. We both were experiencing it but couldn't get a grip on what might be going on. The whole experience was quite disturbing.

Some days we basically forgot all about the feeling and the drowsiness so were otherwise enjoying the ride. When we arrived in Whitehorse, Yukon, I noticed a slight chuffing sound from the rear cylinder as we idled through town. I suspected an exhaust leak but couldn't find anything amiss. The next day we rode to Dawson City and on arrival it was evident that we had a distinct problem with the exhaust. Once settled I removed the heat shields and found the problem; two cracks on the rear header or wye pipe - one at each wye. Also, one nut was now AWOL from the manifold clamp making the problem worse. We were returning to Whitehorse so planned to look after things there. That turned out to be a bust because aside from not having a new wye pipe the Yukon Harley Davidson dealer was awash in repairs and had lost his mechanic. A quick weld job would fix us up but a call to the only muffler shop in town yielded a similar story, so a Plan C was required. We called the dealer in Anchorage and discovered they had a pipe but we would have to make a marathon ride from Whitehorse to Anchorage in two days to avoid sitting out a two-day shutdown. It was a tough ride over some of the worst roads on the trip but we made it, experiencing the drowsiness a couple of times but still not connecting the dots. We were first in line at the shop at House of Harley Davidson on Saturday morning and enjoyed a great breakfast while they mended our ride.

After the job was done and we were riding out of Anchorage, Arlene offered the possibility that our drowsiness/feeling of dread may have been due to the exhaust leak. No sooner did she say that than we could smell oil burning off the new pipe. It seemed reasonable that if we could smell that, we could easily have been breathing carbon monoxide from the leak.

How could that be on a motorcycle? After all, any exhaust should be whisked away to the rear, leak or not. Not so on our bike. It's an Ultra Classic which has not only a main fairing but "fairing lowers" for leg protection as well. This tends to build a pretty nice still-air pocket around the rider, evident when rain drops or a hapless bug float around in the dead air between the rider and the windshield for some time before being whipped away. The fairing lowers extend that dead air space down to the engine. It is my suspicion that wind direction may have had a part in making the condition intermittent. It is also my suspicion that this model of motorcycle would not be the only one that could present this problem.

It turns out the wye pipe crack is a common problem around 70,000 km. on Twin Cam Harleys, so we were right on cue when we were in Alaska. When got drowsy in Nova Scotia two years later at about 130,000 km., we smelled a rat. I removed the heat shields to reveal the start of a new crack in the pipe. That one was fixed up pronto by Ramsay's Harley Davidson in Sidney with little fanfare. Great dealership with awesome service, by the way.

I don't think it would be at all impossible for any bike with a full fairing – touring or sport bike – sufficient to create a dead air space around the motor that could harbour CO from an exhaust leak sufficient enough to impair the rider and/or passenger. My suggestion is to check for exhaust leaks when doing regular maintenance and to not ignore it if one is discovered. I wasn't kidding when I said we had nap attacks; we were both just short of passing out while riding with no warning at all.
